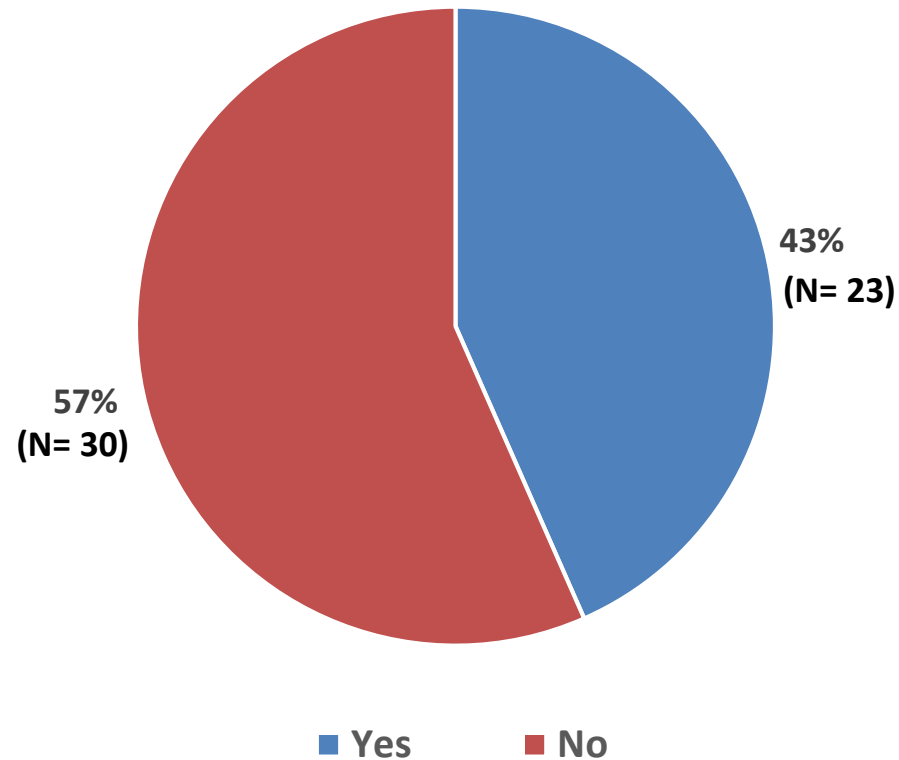

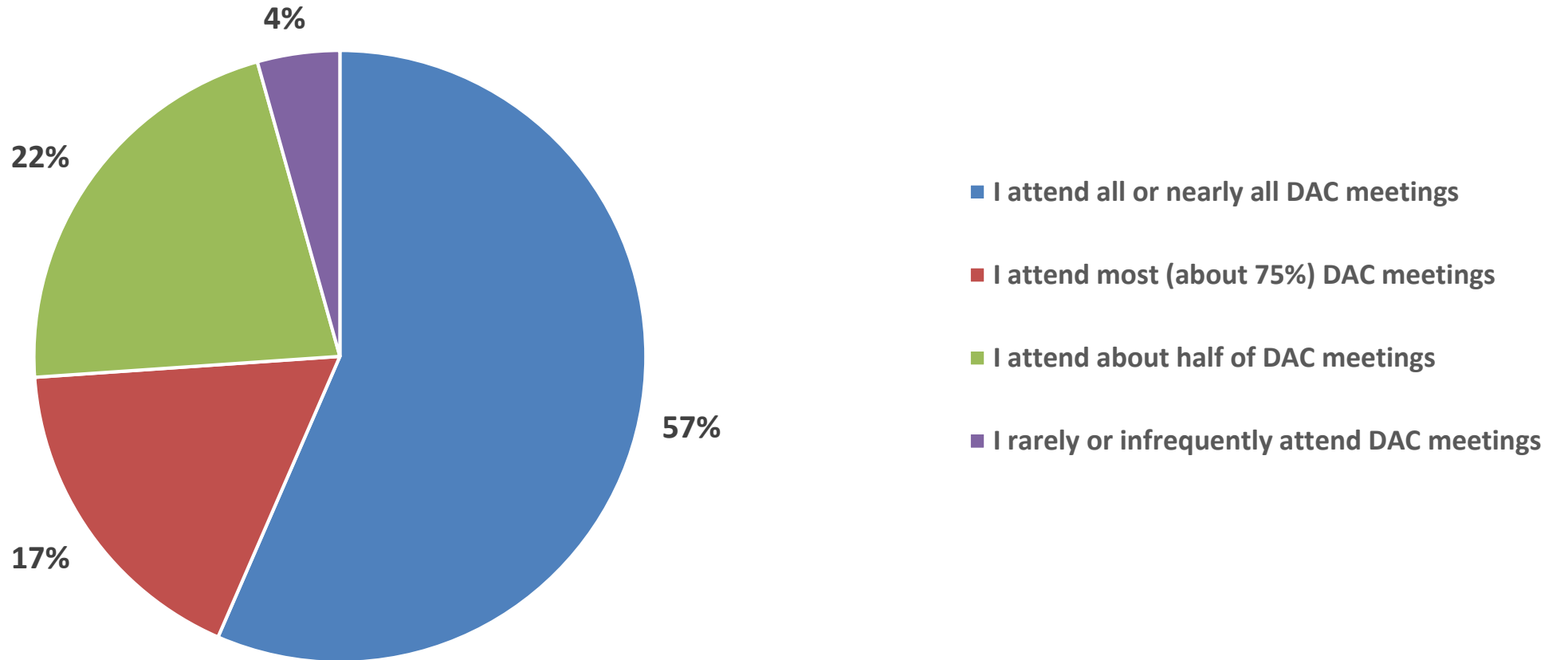

Currently, are you a member of the DAC?



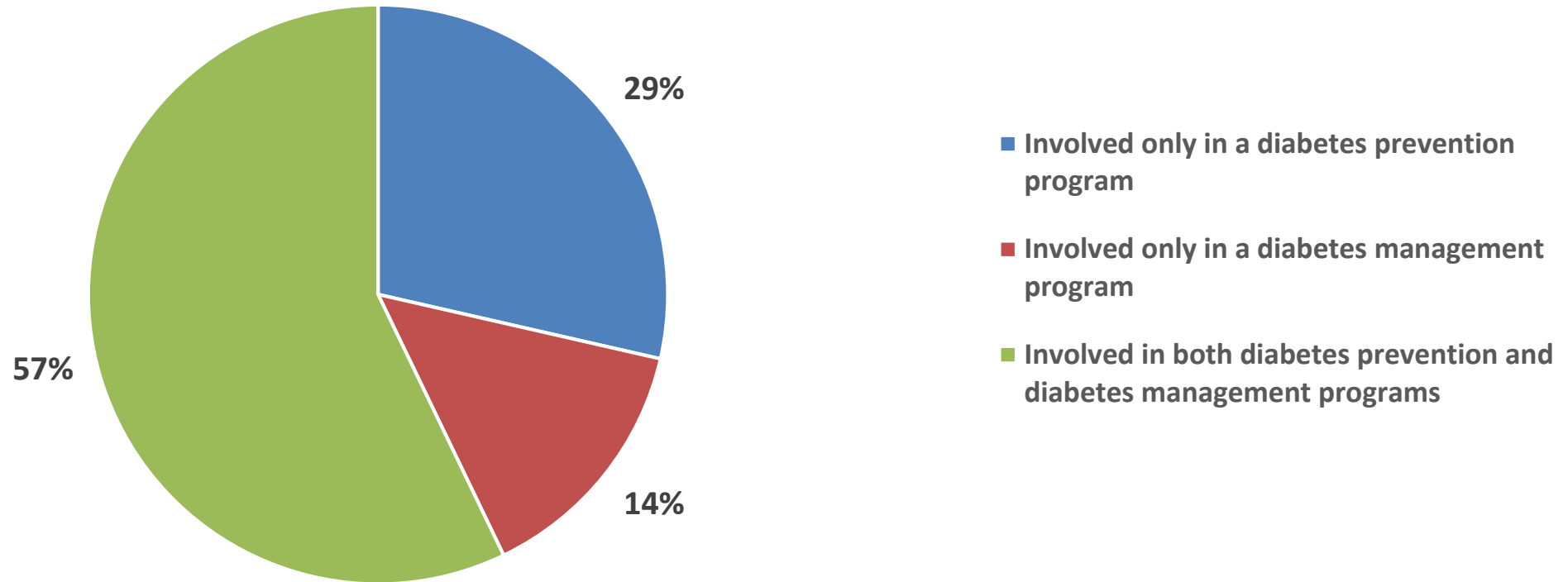
