<p><b>3. 2020 DAC Awards</b></p> <ul style="list-style-type: none"> <li>- Jan Nicollerat shared an announcement of the 2020 DAC Awards, which will accept nominations from June 12<sup>th</sup>-June 30<sup>th</sup>.</li> <li>- The Hugh Young Educator Scholarship (new in 2020) recognizes and financially supports one deserving diabetes educator in North Carolina who has made outstanding and long-lasting contributions to diabetes prevention and/or management. The Hugh Young Award provides a one-time scholarship up to \$1,600 to attend an educational conference or training related to diabetes.</li> <li>- Laura Edwards, Karla Kiriako, and Susan Houston volunteered to serve on the 2020 DAC Awards Review Committee and work with Kristie Hicks to review and score all nominations and scholarship applications.</li> </ul>	No
<p><b>4. COVID-19 and Diabetes in North Carolina</b></p> <ul style="list-style-type: none"> <li>- Dr. Susan Spratt, presented on current data regarding COVID-19.</li> <li>- She shared results from retrospective studies of COVID-19 and patients with diabetes as well as diabetes and risk factors for COVID-19.</li> </ul>	No
<p><b>5. Diabetes Self-Management Education and Support (DSMES) Update</b></p> <ul style="list-style-type: none"> <li>- Corissa Payton, DSMES Quality Coordinator at the NC Division of Public Health presented the statewide DSMES update.</li> <li>- DiabetesManagementNC.com is the new website, developed by the NC Division of Public Health that covers DSMES and DiabetesSmart programs for the state.</li> <li>-</li> </ul>	No
<p><b>6. Diabetes Prevention Program (DPP) Update</b></p> <ul style="list-style-type: none"> <li>- Deb Sanchez-Torrez from the CDC and Nar Ramkissoon from the American Medical Association presented the statewide DPP update by introducing the BrightSpot Initiative for North Carolina and the Growth Team-NC, a partnership between the CDC, AMA and the North Carolina Division of Public Health.</li> <li>- Bright Spots are states that show promise of high potential yield for DPP enrollment.</li> <li>- The CDC identified 4 states to focus on and NC was selected as the first based on opportunities for increased enrollment to the National DPP.</li> <li>- The Bright Spot Initiative’s goal is to enroll 58,000 individuals in a DPP by the end of 2021.</li> </ul>	No
